4:00p.m - Welcome and Call to Order

Karen introduced the minutes and gave a quick overview of the last meeting. Karen shared that as of 11/16/23 there are 48 applications for the foundation grants. She is putting together a New Board Member Orientation manual and it will include statements about the relationship between Northwest Regional ESD and the NWRESD Foundation.

Karen introduces Dan Goldman, NWRESD Superintendent, to share a presentation on Northwest Regional ESD and the organizational structure. Dan shared the following information:

- Northwest Regional has a strategic plan that is rooted in their mission, values, and community input. The strategic plan was created in Fall 2020 and just recently revised and extended to 2026.
- The Strategic Plan contains the following:
 - The ESD's Vision: Every student is educated, equipped and inspired to achieve their full potential and enrich their communities.
 - Six Collective Commitments
 - Strategies supporting each collective commitment
 - Milestones and metrics.



- Each department puts together an action plan each year with their goals and progress based on the strategic plan commitments.
- The ESD provides a Local Service Plan to all the districts they support. The Local Service Plan is revised annually and must be approved by the Board and $\frac{2}{3}$ of our districts that have the majority of students in them. It includes a list of services provided by the ESD, including, instructional services, service menu, etc.
 - 14 districts must approve and it can't be done without Beaverton and Hillsboro.
- NWRESD is expanding access to quality early learning for students with disabilities across regions. They recently purchased a new facility in Hillsboro for early learning.
- Clatsop County Service Center moved to Gray Elementary School (out of tsunami zone).
- Junior achievement is opening a new center in Hillsboro. Junior Achievement program is a program around financial literacy and career engagement. ESD is the prime partner. This program will help a lot of kids get engaged and enrolled.
