LAND ACKNOWLEDGEMENT - Chair Dougherty provided the land acknowledgement.

AGENDA REVIEW/REVISION - Chair Dougherty entertained a motion by Director Riley to move the recognition & good news item to the beginning of the agenda. The motion was seconded by Director Tymchuk and approved unanimously. RECOGNITION AND GOOD NEWS - Kelsey Soltysiak, Communications Director introduced the Tillamook Parent Advisory Committee to the Migrant Education Program of NWRESD. Via an interpreter, family members shared their and their children's experiences with NWRESD programs. Superintendent Goldman and board members asked about programs and events which the migrant program is currently involved with. Superintendent Goldman noted that the NWRESD Foundation may be able to help raise funds to continue the favorite, annual Close Up Washington DC trip for students as well as to expand post-secondary opportunities in the Tillamook area.
