Consulting clinical psychology, mental health staff and teachers meet the student's social, emotional and behavioral needs. Curriculum, instruction and assessment are linked to Oregon State Standards. Students receive 20 hours/week of instruction and an average of 5 hours/week mental health services.  Lifeworks Northwest Day Treatment: Lifeworks (formerly Tualatin Valley Mental Health Services) has contracted with NWRESD since 1987 to provide these educational programs for elementary, middle and high school students placed by school districts and public and private childcare and mental health agencies. The program provides day treatment and educational services to students in grades preschool through high school. All students receive intensive mental health services provided by staff from Lifeworks Northwest. Curriculum, instruction and assessment are linked to Oregon State Standards. Most students are eligible for special education and related services, typically under an emotional disturbance eligibility.  Levi Anderson Learning Center: ODE contracts with NWRESD to provide educational programming for boys placed by public and private agencies in residential treatment at St. Mary's Home for Boys in Beaverton. Average residential stay is 1.8 years. Local districts access educational services for students they place in the	

				program. Boys range in age from 12 to 18 (5th grade - high school). Many students are eligible for special education services, typically under an emotional disturbance or other health impairment eligibility. Curriculum, instruction and assessment are linked to Oregon State Standards. Students receive 22.5 hours/week of instruction and an average of 12.5 hours/week of mental health services.

Motor services are defined by law as a "related service" and must support the specially designed instruction listed on the IFSP or IEP. NWRESD motor team providers serve students birth to age 21. Motor services must be contracted at a minimum of .1 FTE per position.

They practice under licenses issued by TSPC or the Oregon State Board of Examiners. NWRESD employs more than 50 speech language pathologists who provide an array of services to students from birth to age 21 in Clatsop, Columbia, Tillamook and Washington counties.
